Welcome to the INAS Annual Report for 2017. This was a very significant year for the organisation and one in which we have set the foundations for the growth of our organisation in the years to come.

One of the most important moments came in April when the INAS membership agreed far reaching changes to INAS Governance including a new Governing Board structure, election processes and more effective representation for our Regions

Secondly, this was a year of incredible competition with 10 world and two regional Championships delivered, together with sanctioned events in judo and taekwondo. We saw more athletes, from more nations competing in more sports than ever before.

Records were broken with more than 600 new athletes registering to compete at the highest levels – reflecting the fantastic work being done by our member organisations to create opportunities and pathways to international competition.

And we saw new members join us from Bahrain, Morocco and the International Taekwondo Federation.

But perhaps most significant was the launch of trial eligibility groups for athletes with more significant impairments and athletes with autism – opening up international competitive sport for millions more people with an intellectual impairment.

At our heart we remain a small organisation seeking a sponsorship and financial investment breakthrough, but our ambitions, achievements and impact grow with every year. Together, the INAS family is changing the world and we are proud of our success.

I would like to thank all member organisations, committee members, fellow Governing Board members, staff and volunteers for their dedication and commitment throughout the year. And I would like to congratulate all those athletes who competed in INAS competition – this is your organisation and we are proud of and driven on by your achievements.

About INAS

Founded in 1986, INAS is the International Federation for Athletes with Intellectual Impairments. It is a member of the Paralympic family and is responsible for the management of the INAS Global Games and for world and regional Championships in Paralympic and non-Paralympic sports for athletes with an intellectual impairment.

Our vision is that athletes with an intellectual impairment across the world have the opportunity to achieve excellence in sport and high-level competition

INAS is a membership organisation with approximately 70 nations and one International Federation together with INAS regions. We change attitudes, create opportunities and develop pathways in sport to ensure that athletes with an intellectual impairment can progress to elite competition and perform at the highest possible level.

In 2017, INAS amended its legal status to become a Charitable Incorporated Organisation registered in the UK. INAS receives no government or sports lottery support and so each year must raise all the funds required to meet the ever-growing need for support and development.

Often the costs of maintaining the organisation are, by necessity, passed onto our member organisations, and too often, onto the athletes themselves.

INAS benefits from a large team of international volunteers - sports experts, psychologists, anti-doping and medical professionals, sports managers and administrators - all of whom have a passion and commitment for ensuring athletes with an intellectual impairment can compete at the highest possible level and be the best that they can be.

The organisation is led by its Governing Board and supported by a number of sub-committees covering each sport, eligibility, medical and anti-doping specialisms.

Delivery of our strategic objectives and achievements

In 2017, the INAS membership adopted a new strategic plan covering the period to 2020. It sets out the five key objectives that will drive and shape our work. These are set out below together with our progress towards delivery.

 INAS continued the implementation of youthaged competition classes in athletics, swimming and table tennis INAS launched a trial of additional eligibility groups in two sports – table tennis and swimming INAS supported the International Paralympic Committee research center in Belgium to consider the role of adaptive behavior in sports performance Research into the impact of more severe/multiple impairment on sport continue with a post-graduate research study A number of events were attended for data collection purposes Basketball classification processes were finalised and trialled in competition 	 INAS reviewed its governance structures to ensure fairer worldwide representation and to ensure separation of management and governance responsibilities New membership categories were introduced in order to maximize membership opportunities Two new nations and one International Federation were approved as members A new strategic plan was adopted by the membership INAS won funding for a project to develop sport for women and girls, with a focus on Asia, and for a partnership project to develop sport across Europe. 	 INAS continued to develop its sports committees to oversee the management of sport and competition A new medical committee was established to provide specialist expertise INAS saw a significant increase in athlete entry across most sports – with more than 750 athletes competing in World Championships The World Swimming Championships featured a live-stream broadcast INAS invested in its media and marketing to grow awareness of our activities and sport for athletes with an intellectual impairment INAS sanctioned events in judo and hockey for the first time.
